Manufacturer Registration process Flow 2025-26

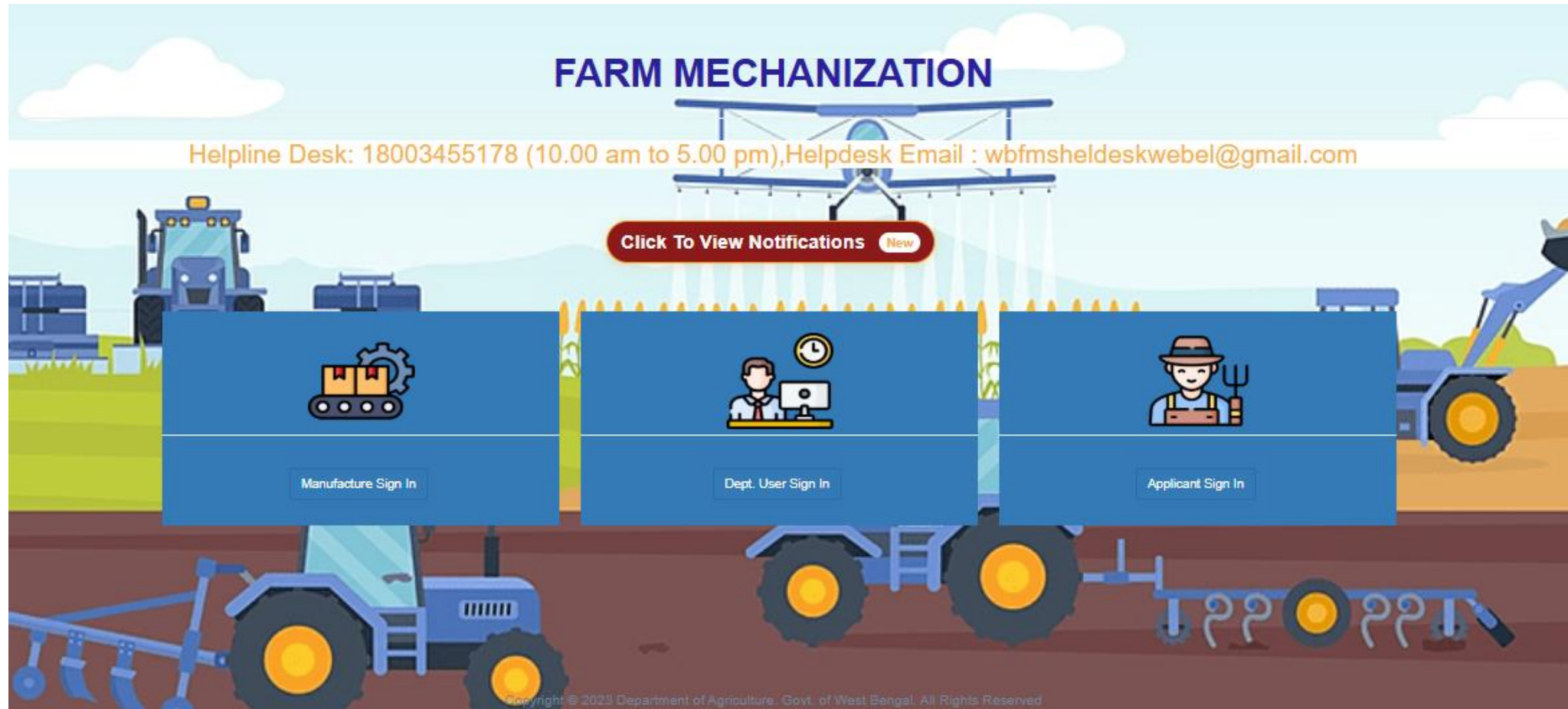

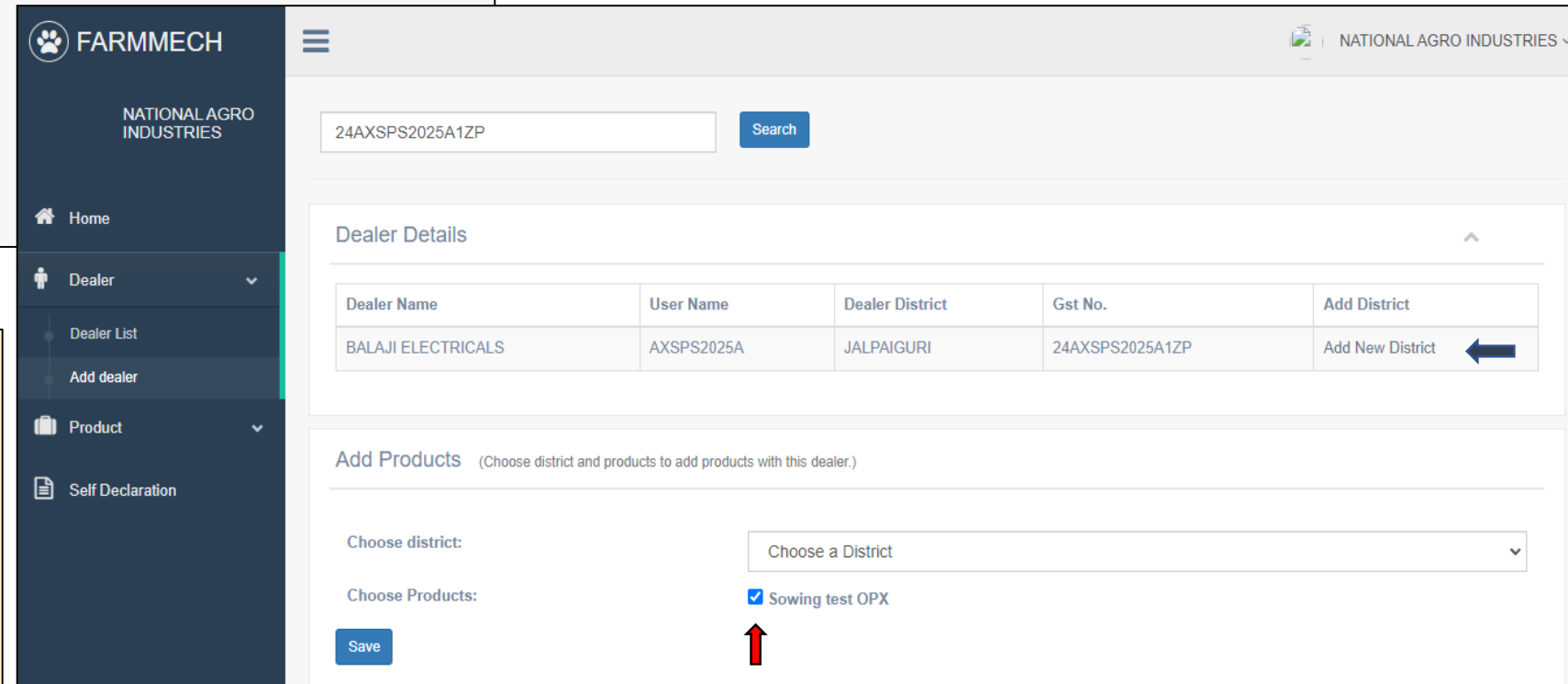
