In terms of Clause VI(ii)(c) of the Guidelines of Farm Mechanization Schemes-2025-26 vide Memorandum No 574 - AG-11030(11)/1/2024-NAB-SEC dated 07.07.2025 , indicative price of 455 nos. of models of different farm machinery/implements have been published vide Memo No.265 (85)-20/HQ dt 12.08.2025 and Memo No.281 (85)-20/HQ dt 26.08.2025 & as per Clause VIII(A) indicative price of 754 nos. models published during 2024-25 will also be valid for implementation of Farm Mechanization Scheme during 2025-26.

As per decision of the meeting of the SPMT held on 22.09.2025 and subsequent approval of the competent authority through e file no DOA-19011(17)/2/2025-AD(DOA)-DOA , indicative price of 319 nos. of models of different farm machinery/implements out of 455 nos. models of 2025-26 & 579 nos. models out of 754 nos. of 2024-25 have been revised in Annexure-A & Annexure-B respectively due to revision of GST of different farm machinery and implements for implementation of Farm Mechanization Schemes i.e. OTA-SFI, FSSM, FMH/FMB and CHC for the year 2025-26 in West Bengal.

Indicative price of rest 136 nos. models of different farm machinery/implements 2025-26 & 175 nos. models of different farm machinery/implements of 2024-25 will remain same as mentioned in Annexure C & Annexure-D respectively for implementation of Farm Mechanization Schemes i.e. OTA-SFI, FSSM, FMH/FMB and CHC for the year 2025-26.

Subsidy amount for a particular model will be provided on the basis of these indicative price( Annexure-A, B, C, & D) subject to maximum ceiling for a category of product as mentioned in the FM Guidelines.

Concerned manufacturers are requested to send a certificate as per format Annexure-E within 07.11.2025 through mail wbfm2024@gmail.com mentioning that they will deliver their products on revised indicative price due to reduction of GST .If any manufacturer is not agreed upon to sell their products on revised indicative price then they will not be allowed to participate in FMS \_2025-26.If any manufacturer does not send the certificate within the stipulated period , it will be assumed that they are interested to deliver their models in the revised indicative price under FMS \_2025-26 .

Revised Indicative Price shall take effect on and from 22.09.2025 & shall remain valid till the date of publication of the Indicative price for the next year by the Govt. of West Bengal.
